### $\frac{\textbf{INTEREST ARBITRATION}}{\textbf{UPDATE}}$

#### **Arbitration Panel**

The three (3) person arbitration panel has been selected and consists of the following members:

- WSC appointed Mr. Ron Cascione as their partial arbitrator
- WTU appointed Mr. Bob Casey as their partial arbitrator
- The neutral arbitrator is Mr. Mike Ryan who was selected by agreement of the two partial arbitrators

The three arbitrators will sit as a panel and will preside over the hearings. The decisions of the arbitration panel are by majority vote.

#### **Hearing Dates**

As of today, the three arbitrators have agreed to two hearing dates. The first hearing will be held on Wednesday, December 16, 2015 and second hearing date is scheduled for Tuesday, January 5, 2016.

The School Committee's attorney, Andrew Henneous, is insisting that the arbitration hearings will be concluded within twenty (20) days of the first hearing which will be held on December 16, 2015. Obviously, this is unrealistic and the School Committee should realize that this timeline cannot be met. In any case, they should remember the following three facts:

- It is important to note that the decisions of the arbitrators are not binding on any matters involving the expenditure of money. The question to ask is: What proposals do not involve the expenditure of money?
- The School Committee filed for arbitration in the past and the result was the arbitration hearings lasted approximately two (2) years and was never concluded and it never produced a contract.
- A contract will only be reached when the School Committee does its job and negotiates a contract.

#### **WORK RELATED INJURY**

is imperative that you notify, in writing, your principal. You also need to contact Margie Brown immediately in the Warwick School Department Human Resources Office so she can explain the procedure to be followed. In addition, you need to notify her by e-mail that you were injured on the job in order to have a record for yourself.
